GENERAL DESCRIPTION

Under the direction of the Commander of the Department of Detention and Corrections, this position administers the planning, design, and construction of major capital projects, and renovations of existing facilities. The incumbent solves a wide range of highly complex, multi-disciplinary problems, which must consider long-term organization-wide planning, composes sensitive, non-routine correspondence requiring tact and diplomacy and/or complex summaries for which established formats generally do not exist, and negotiates with outsiders in sensitive and complex situations. Work consists of complex, varied, non-standardized tasks, requiring application of numerous laws, rules, regulations, and procedures. Errors in work may cause delays in work or losses in expenditures for material and/or equipment or unjustified work time. Work is reviewed through observation and results obtained.

ESSENTIAL FUNCTIONS AND RESPONSIBILITIES

- Serves as Project Manager to include programming, design, and construction of large capital projects, and renovations at the Jail complex;
- Provides technical direction, within the disciplines of architecture and construction, to achieve effective design of large capital facilities at the Jail complex;
- Directs the construction process related to both large and small capital projects;
- Acts as liaison between office personnel, County employees, architects, contractors, and other professional entities to insure that goals and procedures are understood in the planning, design, and construction of facilities; includes incorporating an operational knowledge of the criminal justice system into facility design;
- Prepares written reports, communications, schedules and project updates as requested;
- Provides cost analysis and budget control on capital projects, to include developing a value management program on all projects as wells as the development and coordination of furniture, fixtures and equipment (FF & E);
- Directs the programming and space planning functions involved in facility design;
- Prepares a master plan and site analyses for all Office facilities at the Jail complex;
- Participates in Sheriff's Office recruitment and community relations activities as directed.
